

REGULAR COUNCIL MEETING MINUTES OF THE CITY COUNCIL OF NEOGA HELD IN CITY COUNCIL CHAMBERS, MUNICIPAL BUILDING, 533 CHESTNUT DECEMBER 1, 2008, AT 7:00 P.M.

CALL TO ORDER

The meeting was called to order at 7:00 p.m. by Mayor Russell and the Pledge of Allegiance was recited. Those present were: Commissioners Lindley, Kepp, Varner, Modglin, Mayor Russell, and City Clerk Evans. Others present were Public Works Superintendent Stan Hagerstrom, City Treasurer Diana Foor and Brian Kidd.

MINUTES

After reviewing the regular session minutes from November 17, Commissioner Modglin made a motion to approve the minutes as presented. The motion was seconded by Commissioner Varner. Ayes, Commissioners Modglin, Lindley, Kepp, Varner and Mayor Russell. Nays, none. Motion carried. 5-0.

CCDC AND COLES CO. REGIONAL PLANNING CONTRACT

The Council discussed the proposed CCDC and Coles County Regional Planning contracts that were presented to them. After little discussion, Commissioner Varner made a motion to approve the contracts. The motion was seconded by Commissioner Kepp. Ayes, Commissioner Varner, Modglin, Lindley, Kepp, and Mayor Russell. Nays, none. Motion carried. 5-0.

2008 TAX LEVY

The City Council reviewed the proposed 2008 Tax Levy. City Clerk Evans told the Council that the proposed numbers where calculated by increasing last years number by 5%. PUBLIC PROPERTY

SUPERINTENDENT HAGERSTROM REPORT

Superintendent Hagerstrom reviewed his report with the Council. Hagerstrom explained that the sewer telescan was being done, and the sand spreader is being worked on. Commissioner Lindley asked how soon the hydrant would be replaced and Commissioner Kepp reminded Hagerstrom how important is was to get sand down at the railroad crossings in the early mornings. Kepp also asked if anything could be done about the leaves that are lying in the ditches around town. Kepp is concerned that the tin horns will become clogged up and flooding will occure.

STREETS AND ALLEYS

STREET LIGHT IN ALLEY BEHIND CHURCH

City Clerk Evans explained that AmerenCIPS came to the City asking if they would be interested in placing a pole light in the alley between the Grace United Methodist Church and the Neoga Fire hall. Commissioner Modglin said that he feels there is enough light there at this time, and the remaining Council agreed.
