## CALL TO ORDER

## COMPUTER / VIDEO EQUIPMENT PURCHASE FOR THE POLICE DEPARTMENT

Police Chief Gerald Mattern explained to the Council that he has completed additional research on the video equipment, and after talking to numerous companies he has ordered new video equipment that will work with the existing computer system. The equipment that he ordered will be approximately \$650 cheaper than previously approved. The Council thanked Chief Mattern for continuing to work on saving money.
