

# REGULAR COUNCIL MEETING MINUTES OF THE CITY OF NEOGA HELD IN THE CITY COUNCIL CHAMBERS, MUNICIPAL BUILDING 533 CHESTNUT AVENUE, NEOGA, IL OCTOBER 15, 2024

#### TREASURER'S REPORT

#### FISCAL YEAR END 2024 AUDIT REPORT

Auditors Kelsey Swing and Heather Kuykendall presented the FY 2024 audit to the Council. The auditors explained the financial records, and that the city had a clean audit.

## PUBLIC PROPERTY, COMMISSIONER LETIZIA

Commissioner Letizia said that he did not have a report, but wanted to know why the IDOT Shared Path project required a silt fence to be installed. City Clerk Evans explained that it was required by the State of Illinois grant. Evans also explained that the fence should be removed before October 31<sup>st</sup> for trick or treat night for safety reasons.
