#### CALL TO ORDER

#### **UPDATES FROM MILANO & GRUNLOH**

Engineer Lee Beckman handed out the project update sheet to the Council and explained the following:

- Wastewater Treatment Plant nothing new.
- ITEP is complete, other than the seeding, which will not be done until after March 1<sup>st</sup> or when the weather breaks. They will then schedule an IDOT walk through.
- Water Line Grant contractor is scheduled to start after the first of the year if weather permits.
- Lead Service Line Inventory The bids have been awarded, and paperwork will need to be signed.
- Rebuild II/RISE Grant Nothing new to report. Beckman said that he assumes the grant announcement will be soon, and if the city might want to talk to local politicians about the grant.
