

# REGULAR COUNCIL MEETING MINUTES OF THE CITY OF NEOGA HELD IN THE CITY COUNCIL CHAMBERS, MUNICIPAL BUILDING 533 CHESTNUT AVENUE, NEOGA, IL NOVEMBER 24, 2025

#### CALL TO ORDER

The meeting was called to order at 7:00 p.m. by Mayor Helm. The Pledge of Allegiance was recited. Those present were Commissioners Williams, Schabbing, and Mayor Helm. #### **PURCHASE OF SONIC WALL**

The council reviewed a quote from SDS for a new Sonic Wall. Commissioner Schabbing made a motion to purchase the new sonic wall for \$2,150 that included a three (3) year contract. Commissioner Williams seconded the motion. Ayes, Commissioner Schabbing, Williams, and Mayor Helm. Nays, none. Motion carried. 3-0.

#### FINANCE, COMMISSIONER SCHABBING

ORDINANCE #1128-12-2025 An Ordinance Levying the Taxes for the Corporate Purposes of the City of Neoga, Cumberland County, Illinois, for the Fiscal Year Commencing May 1, 2025, and Ending April 30, 2026

City Clerk Evans explained that Ordinance #1128-12-2025 was for their review and would be presented at the next meeting. Evans explained that the proposed tax levy was at the maximum rate of 5% to capture any new construction.

Community Facilities Grant – no change

IDOT – This was announced and not successful.

Street and Alley Resurfacing – a pre-construction conference was held on November 3<sup>rd</sup>, and the contractor plans to start this week.

City Hall parking lot – the low bidder was Esker and Walker at \$65,488.64. They plan to do the work in the spring.

Watermain Relocation – still working on the plans for the water main relocation at the interchange. The lowest bidder was Kieffer Bros. Construction at \$192,848.04.

#### PAY ESTIMATE #7 FOR WATERMAIN REPLACEMENT PROJECT

After review, Commissioner Schabbing made a motion to pay estimate #7 for \$91,721.46 for the watermain replacement project. Commissioner Williams seconded the motion. Ayes, Commissioner Schabbing, Williams, and Mayor Helm. Nays, none. Motion carried. 3-0.

#### MILANO & GRUNLOH INVOICE #32265

The Council reviewed invoice #32265, which included miscellaneous services. Commissioner Williams made a motion to pay the \$8,551.25 invoice. Commissioner Schabbing seconded the motion. Ayes, Commissioner Williams, Schabbing, and Mayor Helm. Nays, none. Motion carried. 3-0.

#### STREETS AND ALLEYS, COMMISSIONER EDWARDS

#### HEALTH AND SAFETY, COMMISSIONER WILLIAMS

Police Chief Schabbing discussed with the council the need to remodel the police department. Schabbing presented the designs from the previous year. It was the consensus of the council to proceed with new cost estimates.
